RE: St Bricins and St Mogues - West Cavan School Amalgamation

Dear Minister McHugh,

We write to you on behalf of the communities of Belturbet and Bawnboy, Co Cavan in relation to the retention of St Bricins College and St Mogues College and our concerns around the proposal by CMETB in relation to amalgamation of schools to another separate town, Ballyconnell.

While we very much welcome the announcement of investment of €15 million euro to the upgrade the provision of education in West Cavan, as confirmed by the CE CMETB in November 2018 to the Anglo Celt newspaper, we have significant concerns about the approach and decision making process being applied by CMETB with regard to this proposal.

In November 2018 the CMETB put a motion to their board to amalgamate two schools in two separate communities, 20 km apart, and build a new school in Ballyconnell. A proposal that was being presented for the first time and yet a decision was sought at that very meeting. This proposal would result in the closure of two schools and remove any second level education facility in those communities.

This would seem to be a project of significance and yet when this was put to the board of the ETB and later that day to the board of management of schools, there was no feasibility study, no robust research into other options for the provision of second level education in West Cavan. By other options we refer to retention of existing schools and building on the excellent services being provided and connectivity with the local communities. This all occurring, despite lack of approved funds being received in recent years, specifically St Bricins College, a school which has been purposefully starved of funds as highlighted in the attached article.

Failure to expand schools laid bare

A LITANY of failed attempts to add to facilities at St Bricin's and St Mogue's are detailed in a series of documents obtained from Cavan and Monaghan Education and Training Board (CMETB).

It follows an application made by this newspaper under Freedom of Information.

The documents obtained cover a period of five years, and a detailed analysis of minutes of meetings shows where repeated attempts to add to the two schools sites have failed to materialise. In September 11, 2013, four new classrooms were sanctioned for St Bricin's; while at the same time an architect was brought in to St Mogue's to sketch out plans for additional accommodation.

 Honal accommodation.
 By January 2014, the St Bricins' plans were develdoped but St Mogues learned proposed works 'presented a mumber of design challenges', e primarily due to 'limitations of o the site'.

It wasn't until late 2015 that, following a 'change of brief', the Department sanctioned the additional accommodation project for Belturbet. There is no mention of additional classrooms at St Mogue's, however funding is obtained in the interim to ensure fire and safety regulations are complied with and the science room is refurbished.

In January 2015, the Department agrees to a further 'change of brief' to proposed

works at St Bricin's and a new Design Team is required. There is note of further changes being made to the brief in May and July 2016, while additional 'temporary accommodation' is approved and installed on site.

It's not until January 2017, three years and several brief changes later, that a design team is finally appointed and tenders for the work carried

Two site meetings take place in May 2017 and Stage 1 Pre-

liminary Design reports are under review at the Depart-

In September of that same year, the ETB is instructed by the Department to reduce the scope of the proposed project in line with the level of accommodation approved and available funding'. A revised submission is sent back to the Department in October.

October. A Design Team meeting for works at St Bricin's, scheduled with the Department for

December, is cancelled. That meeting, the Celt understands, is still awaited.

understands, is still awaited. There is no mention of the additional accommodation at St Mogue's, save for an approved extension to bathroom facilities.

In October, Director of Schools at CMETB Paddy Flood concludes a report titled 'Demographic Considerations for Single CMETB school in West Cavan', the details of which are ratified at a Board meeting in November

Governance questions need to be asked and answered regarding the progression of a project by CMETB with such serious consequences for two rural, border communities. In particular, the lack of a full and detailed feasibility study, robust and inclusive stakeholder engagement, and confirmation of funding to the amount of 15 million from DES. How can a board make a well informed decision to close two schools, which are long embedded in the community, St Bricins has been in place for 80 years, without this type of information? This is a public service and those making decisions are accountable for the operations and allocation of resources to the communities they serve. The total lack of engagement with the community on this proposal is shocking and indeed put the people in those areas into shock when it was announced last November, 2018.

In a recent Dail debate TD Mary Mitchell O'Connor represented on your behalf and responded to queries presented by TD Brendan Smith in relation to the schools proposal by CMETB. In reference to the level of engagement that should occur, TD O'Connor advised that

Any such proposal to amalgamate schools must involve consultation with all the relevant stakeholders and follow decisions taken at local level. If I can just comment on that, stakeholders have to buy into an amalgamation for it to be a successful one. In that regard, any proposed changes must be well planned and managed in a manner that accommodates the interests of parents, teachers and local communities and contributes to an inclusive education system. If I may add, students' views must also be taken into account. Any proposals are then subject to the approval of the Department of Education and Skills.

In addition went on to advise that CMETB have recently

advised the Department that a series of meetings with stakeholders has taken place and further consultation meetings are planned. The object of the consultations was to provide additional information on the proposed amalgamation of both schools and to ensure that any concerns raised are heard and taken into account.

This we can assure you is not the case. The announcement was made in November 2018, with zero consultation or local engagement. In January 2019 an invitation was extended to the CE CMETB to attend a Public meeting in Belturbet Civic Centre as an opportunity to engage with the community and below is the response:



The CMETB and Board of Management of both schools are under the remit of CMETB and it would be a given there is some engagement; however this is not intensive by our understanding. The lack of engagement has been previously highlighted in the Anglo Celt newspaper:

Editor, We write on behalf of a committee working to keep St Mogue's College Bawnboy open. The committee is comprised of parents of current and prospective students of St Mogue's and concerned residents of Corlough, Swanlinbar, Glangevlin, Currin Ballyconnell, and Bawnboy

We would to like highlight the complete lack of consultation leading up to the CMETB's decision to build a new school in Ballyconnell and close St Mogue's and St Bricin's. This is in stark contrast to the approach taken in Clones where the two schools amalgamated were in the same town and not 20km apart, as is the case with St Bricin's and St Mogue's. Consultations took place with parents of feeder school children and parents of pupils already attending the Clones schools. A further example is the threatened closure of a school in Bagenalstown, Co Carlow. The ETB instigated a public meeting to which ALL interested parties were invited on announcement of their plan.

The fact that the St Mogue's Parents Association had to actively pursue a meeting with the CMETB - which has not yet taken place - portrays what we feel is a complete disregard towards St Mogue's stakeholders, particularly parents.

In the CMETB press release of November 2018, it was stated that subject choice will improve. We question the evidence to support this

assertion. St Mogue's already offers 24 subjects, which equals or betters many larger institutions. A many target institutions. A larger school may lead to greater restriction of subject choice due to timetabling constraints and is also likely to lead to a cut in teaching resources as a result of the proposed amalgamation, as inferred by the article in *The Anglo-Celt* of February 7, 2019. It is clear from statistics on the Department of Education's website that there are many schools throughout the country with under 200 pupils, which continue to flourish and appear not to be threatened with closure. In addition, the excellent results (both academically and sporting) achieved by pupils by St Mogue's to date fail to

be recognised. On their website the CMETB state that their 'Second Level schools form an essential part of the communities in which they are located'. Has St Mogue's suddenly become superfluous in an already disadvantaged rural community? Work on St Mogue's College was completed this September including

a new science laboratory, suite of toilets, widening of corridors, an extension to the canteen and a complete rewiring. Is this further evidence of taxpayers' money being wasted? In terms of the development.

of facilities at St Mogues, th was an offer made to the CMETB to collaborate on indoor sporting facilities with Templeport St Aidan's GAA club in Bawnboy. However, this proposal was not accepted by the CMETB. This type of crosscommunity cooperation is actively encouraged by the Department of Education and would save a lot of money.

Enrolments to St Mogue's have doubled since the new principal took over in 2006. There may be scope for St Bricin's to increase should some of the monies be used to attract new enrolments. Belturbet's population has increased and is expected to continue to grow with further new houses planned. The choice of parents to

send children to single sex or denominational schools should be respected. It has been acknowledged by the CMETB that children on the periphery will be ineligible for free travel due to catchment area restrictions and this may increase the ssure on already overwhelmed schools in Cavan. How can this proposal be entertained as practical?

The Department of Education's action plan 2016-2019 states that they will "revise protocols to ensure no small school closes against the wishes of parents". The Minister must have the last word on this.

To date the engagement with the community groups named above has been non-existent. Because of the lack of contact we had to reach out to the CE of CMETB and seek engagement. We initially did this in April, 2019 and also sought a public meeting for the ETB to engage the communities. To date the ETB have declined this public meeting engagement and in fact have indicated they will only meet with a small delegation of reps when the occasion comes. The CE CMETB met with the St Mogues Parents Association in March at their request and they specifically asked that it not be noted as engagement but a clarification meeting on the announcement by the ETB, However the CE has referenced this as engagement despite the request by the parents on the type of meeting it was. On 12th March in an article in the local paper CMETB stated they had made contact with the Chair of St Mogues Save Our School Committee, when in fact they only received a letter on the 18th March, a week later.

Thank you for forwarding the procurement procedures. I would like to follow up with you in relation to the stakeholder engagement you have referenced. In the last number of days the committee has followed up with the community groups and parents and their feedback would appear to be at odds with your clarification on the engagement activity up to these recent emails. I have below provided the details of the feedback.

• St Mogue's College Parents Association - meeting (first and only) held on the 11th March at the request and invite of the Parents Association, not initiated by CMETB

St Bricin's College Parents Association - have not been met or consulted with to date by CMETB

Community Groups, including your Committee - neither the Save Our Schools St Bricins Belturbet Committee or St Magues Bawnbay committee have been met or consulted with

For clarity and to ensure the lines of communication are accurate, please provide details of the formal engagement referenced in relation to the above community and parent representatives. In addition you may wish, as part of the extensive stakeholder engagement planned by CMETB, to include the local youth services and GAA clubs in the affected communities.

I have also attached a copy of recent correspondence issued by CMETB to St Mogues, the content would seem to suggest that the feasibility study has only just been formally communicated. Certainly the first news of this for the community and parent groups was the article in the Anglo Celt Newspaper on the 3rd April.

The CMETB proposal is of huge concern to the people living in these rural communities and so far their voice has yet to be heard in a meaningful or engaged manner.

In this correspondence dated 24th June, 2019 the CE CMETB states his "disappointment" and hopes for no further delays in meeting. This was raised with the CE who makes claims of having an agreement in December 17th 2018, with a committee member to meet with the St Bricins Committee. Something which was impossible at the time as no committee was formed until January 2019. The CE will not provide the name of the person he engaged with, and of note did not follow up in the months that followed, somewhat incongruent with the stated desire to engage.

Disappointingly the long anticipated feasibility report turned out to be an architectural report (appendix 1) and is without an author. The report itself is of a poor standard with outdated information from 2011 and various elements of the building missing. It is remarkable to think this being presented by CMETB as a feasibility report which would be completed with *"the assistance of an external and professional design team of engineers and quantity surveyors"* as stated by the CE of CMETB in the attached newspaper article. He goes on to say this would include a cost analysis, there are no costings identified in the architectural report, not surprisingly as it is a shambles of a report using a copy and paste of old information from 2011, <u>8 years ago</u>. Of note both schools have confirmed no person(s) attended at the sites to inform the content of this report.

Based on the poor quality of the report, and clear lack of interest in a robust, well scoped brief, the Committees and Parents Associations have been forced to postpone the agreed meeting scheduled for the 11th July with the CE of CMETB. We are unable to engage in a meaningful way when this is the standard of the approach been taken.

CMETB is to engage an independent consultant to examine the feasibility of the existing St Mogue's and St Bricin's school sites to accommodate kin required extensions. It follows heightened presthe sure placed on the educa-

est tional and training board to explore all options beyond their announced proposal to shut the two west Cavan schools in favour of building a new €15 million facility in

a neighbouring Ballyconnell. The revelation that an outside party had been called

in emerged after a recent CMETB meeting in Virginia College, and against a backdrop where CMETB has thus far received no formal response from the Department of Education in relation to the replacement school plans.

Following the meeting, Mr Kearney informed *The Anglo-Celt* that consultations were ongoing at local level with various stakeholders, "particularly with the parents' association of St Mogue's at present, with a view to examining if the school was to remain, what investment would be required to support it".

In relation to Stapport in 'S, Mr Kearney explained: "I am due to meet with more parties there in relation to that school. I have also met with Ballyconnell Development Association, very strong support being voiced there for the new school."

Any feasibility study would be drafted with the assistance of a external and professional design team of engineers and quantity surveyors, and would focus on the type of extensions that would be required at both schools, including PE facilities. "It will be scoped out from a cost analysis," explained Mr Kearney.

Facilities needed

Both schools have been advocating the need for PE facilities for the last 30 to 40 years, Mr Kearney accepted. "In terms of special needs requirements - specialist areas - modern facilities in terms of staff rooms, meet-

ing rooms, parent meeting rooms. The whole motivation of the CMETB Board is to ensure that the quality of facilities in West Cavan and Belturbet should be on a par with their counter parts right across the rest of the Cavan region and the Monaghan region," he added

Nine out of the 11 schools in the CMETB area have seen their enrolments jump significantly in recent times.

While the enrolment numbers at St Bricins was "slightly down" on last year looking toward September 2019, St Mogue's new pupil numbers have remained steady.

"When parents see the range of facilities on offer at schools in Cavan town, it does

lure students away to attending those schooling facilities in Cavan Town. Not withstanding the fact that there is excellent teaching and learning taking place in St Mogue's and St Bricin's."

He congratulated St Mogues on collecting a brilliant Ulster title on the football front, and St Bricin's which last week won a national award in the realm of Physical Education under the tutelage of the Deputy Principal, James Sherry.

The Chief Executive said the significant enrolments overall at all CMETB schools was a "tremendous endorsement" of the teaching and learning that is taking place through out the Cavan and Monagharegion.

In our communication to CMETB regarding the postponement of what was meant to be our first meeting, we included a copy of retort to the architectural report from both communities. They are attached as appendix 2 and 3 for information.

This matter is very serious, for the young students present and future, the families and people of both communities, and yet little regard is been show to us, we are tax payers and voters and more is expected of our public service. In addition the damage that is being done to both schools is a serious risk factor, undermining the profile of both schools, with the recent example being the resignation of

the Vice Principal of St Bricins, a well-regarded professional, and a huge loss to the school, who has left to take up a position in education services outside of the ETB remit.

The lack of clarity about the schools future, the poor management of the process is inexcusable and we ask that this proposal by CMETB be stood down and real engagement begin in terms of how this funding can be best allocated to the two existing schools which are at the heart of their communities for some time, achieving excellent results because of the type and size of schools they are. They have been delivering outstanding educational and personal development outcomes for the young people who journey through those halls. We have already submitted 1000's of petitions signatures and letters from the community saying clearly they do not want the new school, but want St Bricins and St Mogues to be retained, refurbished and sustained for the future of school services that match the need of students in rural Ireland today.

It is clear that the level of engagement indicated by CMETB to your department is being misrepresented.

Minster on a final note, we have sought a meeting with you to talk through our concerns and explore our ideas on options for both schools and to hear your thoughts on the CMETB proposal; we would welcome a date for this meeting. We would also welcome acknowledgement from you personally on this significant matter and our earlier detailed file submissions on St Bricins and St Mogues. We ask that this does not linger as it is damaging to the schools and all those involved. These rural communities needs support not withdrawal of services.
